PLEASE NOTE BEFORE BRINGING YOUR VESSEL TO PIER 39 MARINA, THE FOLLOWING TRANSACTIONS MUST BE COMPLETED:

- 1.) COMPLETE APPLICATION SUBMISSION (No Missing Documents)
 - DMV REGISTRATION or COAST GUARD DOCUMENTATION
 - PROOF OF RESIDENCE (LAND BASED UTILITY BILL OR LEASE IN APPLICANT'S NAME)
 - PROOF OF INSURANCE (MUST BE CURRENT AND IN APPLICANT'S NAME)
 - SURVEY (W/JIN 3 YEARS, IN THE WATER OK) REQUIRED FOR ALL VESSELS +25 YEARS OLD AND ALL WOODEN VESSELS
- 2.) APPLICATION APPROVAL
- 3.) RESUBMISSION OF INSURANCE WITH UPDATED ADDITIONAL INSURED'S LISTED
- 4.) FULLY EXECUTED AND SIGNED DOCUMENTS
 - LEASE AGREEMENT
 - NON-LIVEABOARD AGREEMENT
 - NO PEER TO PEER RENTALS ACKNOWLEDGEMENT
- 5.) TOTAL DEPOSITS AND RENT PAID IN FULL
